**SUBJECT ALERT ACTIONS ON VESSELS INVOLVED IN RICE  
SMUGGLING AND OTHER NEFARIOUS ACTIVITIES**

The illegal activity of rice smuggling is rampant and has been going on for some years cheating the government of huge amount of revenues. In view of this, the Special Projects Action Group of the Presidential Anti-Organized Crime Commission (PAOCC) of the Office of the President, has embarked an operation against rice smuggling in coordination with the Bureau of Customs (BOC), Philippine Ports Authority (PPA), Maritime Industry Authority (MARINA), Bureau of Immigration (BI), National Coordinating Agency (NICA) and the Department of Finance (DOF).

In a coordinative meeting held on 14 September 2001, the PAOCC released the following list of vessels reportedly involved in rice smuggling:

All concerned MARINA Offices, including the MARINA Maritime Regional Offices (MRO's) are hereby directed to immediately initiate proceedings relative to the revocation/cancellation of Certificate of Public Convenience (CPC), Certificate of Vessel's Registry (CVR) and Seaman's Identification Record Book (SIRB) to captains, mates/crew of the vessels involved in rice smuggling. You are further advised to be on guard on any attempts by the owners/operators of listed vessels to sell/dispose/transfer or change the vessel's name/vessel registry and/or other devious means to avoid the vessels apprehension/seizure/litigation

In this likely event, any such application for change of name/sale and transfer or registration should be immediately denied. The vessel owner/operator should also be advised to voluntarily turn over the vessel to customs authorities.
