The Applicant shall publish this Order once in a newspaper of general circulation, or shall post said Order in the MARINA website, at least ten (10) days prior to the above date.



The Applicant shall submit a written Formal Offer of Evidence (FOE) during the hearing or five (5) days thereafter.
